Good morning Brooke,

Thank you for referring this LPS amendment to us for comment. The proposal is minor in nature and should not affect the Water Corporation's ability to service the site, or future redevelopment.

For reference purposes, I have attached a screenshot of the existing water and sewer pipes around the site. Future redevelopment, particularly on No.3 Main Street, will need to be adequately set back from the existing gravity sewer that runs on a diagonal alignment inside the rear boundary of the property. The landowner can obtain further advice from us about the sewer at the appropriate time prior to submitting a building application.

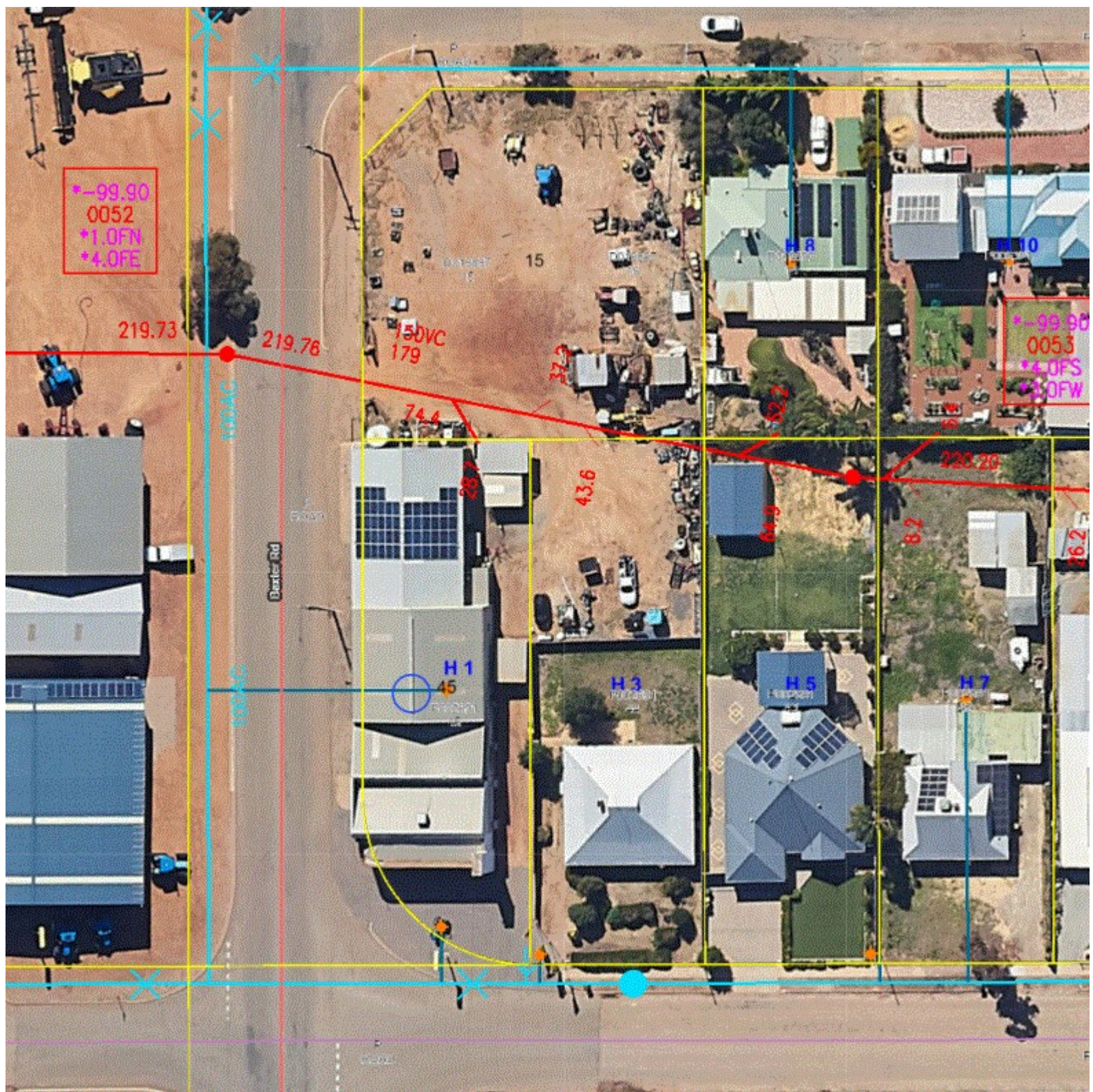
